ADDITIONAL ARRANGEMENTS – PLEASE READ IF EXTENDING AFTER THE DANCE TOUR

The group must fly together from Australia to Hong Kong. At the end of the Dance Package your family may request to extend their stay in Hong Kong – subject to availability. Air tickets cannot be changed to Round World tickets or to return home via another continent or another country. Return date change quotes can be requested. The pricing will be the airfare difference between the original date and the new date.



DANCE AROUND THE WORLD BOOKING CONDITIONS - GROUP BOOKINGS

Please read the following carefully before signing our Booking Form. This sets out the Booking Conditions, Cancellation Fees and Trade Terms.

Dance Around The World and MTA Travel act as a third party on behalf of the suppliers eg hotels, bus companies, performance venues, dance studios, tour guides etc. We cannot be held responsible for any increases or other adjustments in price imposed by third parties which may occur between now, and your date of travel.

Very IMPORTANT - **Currency exchange** with overseas suppliers can affect costs even after a deposit has been paid – a currency adjustment may be necessary and will be added to your Final Invoice. **Your costs have been based on the current rate of exchange, when your Studio or School was quoted the Tour price.**

AIRFARES

If Qantas Airways increase their airfare costs at any time up to ticketing/final payment date this increase will be passed onto to group participants. At the time of the increase announcement passengers can choose to pay for the airfare portion of the package prior to the Final Payment Date to avoid any further increases. Taxes quoted are approximate and are subject to change till your Airline booking is ticketed. Please call our office anytime if you would like a current update.

DEPOSIT

DEPOSIT 1 - A non refundable deposit of \$500 per person is due to hold your place on the group by the due date on your Booking Form

DEPOSIT 2 - A progressive non refundable deposit of \$1500 per person will be required 5 months after the initial deposit – please send this deposit directly to us by the due date to keep your place on the Tour. The date due will be on the bottom of your Invoice. You will have an Account number on the top of your Invoice.

*Should the group not reach the minimum numbers of passengers required (38) within 2 weeks of the deposit date we will refund your deposit in full.

*Once the numbers are attained the deposits are non refundable.

*If numbers drop to below 38 after this date and the group decide not to travel the deposit is non refundable.

We can provide a quote for the group to travel below the minimum 38 passengers, however the cost will be higher than the original quotation.

PERFORMANCES

Performance Opportunities are provided by third parties. Dance Around the World cannot be held responsible should these opportunities be withdrawn without notice. Performances may or may not be advertised on day of performance at venues. Audience numbers cannot be guaranteed by Dance Around the World at any venue. Some venues may be outdoors, if inclement weather we may not be able to re-schedule the performance.

DANCERS

Each dancer must be accompanied by an adult guardian/parent over the age of 18 years who will be fully responsible for them for the duration of the tour. **20 Dancers must be 6 years old (maximum 18 years)** to participate in the pre parade at Disneyland Hong Kong. Dancers and their chaperone must purchase full Air and Land Package for the Dancer to be able to participate in performances and workshops.

Please note all performances are outdoors. If inclement weather we may not be able re-schedule.

FINAL PAYMENT is due 2 months prior to departure. A date will be advised with your Invoice. Final Invoices will be emailed to you 2-3 weeks prior to your Final Payment date

METHODS OF PAYMENT

The preferred method of payment for your Final payment is cash, direct deposit or credit card. We accept payment by the following credit cards Mastercard or Visa (1.2% merchant fee applies) American Express (2% service fee applies).

GOVERNMENT FEES AND AIRPORT TAXES

Air taxes and Government charges are levied on all air tickets from Australia. In addition, foreign government fees and airport taxes may be applicable on your journey. **Certain airport taxes must be collected before departure** and will appear on your airline ticket. We have no control over the pricing on these charges and they are subject to change up until the air ticket has been issued by the airline.

TRAVEL INSURANCE & HEALTH

Travel Insurance may protect you against the costs of unexpected illness, accidents, lost or stolen luggage or unforeseen circumstances. It may cover you for some Covid-19 related circumstances. If you or any member of your travelling party have any medical condition, which may affect your insurance cover, or if you have seen a doctor in the past 60 days please advise us as you may need to have your doctor complete a Pre-Existing form. Please ensure you consult your doctor or TMVC (Travellers Medical Vaccination Centre) for up to date requirements worldwide.

We recommend all passengers have Travel Insurance from when their first deposit is paid. We suggest you contact Covermore Travel Insurance 1300 72 88 22 to discuss your upcoming trip and specific situation and obtain a quote.

FREQUENT FLYERS

Frequent flyer points can be accrued on some airfares.

GROUP TOUR COSTS

You are booking on Group Package tour. Air Taxes have been quoted separate. DATW do not give an itemised breakdown of each component in the Dance Tour or Dancers Package

PASSPORT REQUIREMENTS – Australian Passport Holders

A current passport with at least SIX (6) months validity from the date of your return is required for all international travel. Visas and passport validity are at all times the **full responsibility of the traveller**. Australian Passport applications must be made through your local Australia Post Office. Please let us know if you require any assistance with visa's. If you have a criminal record you may be refused entry to an overseas country- this can include minor offences such a drink driving – please check with that country's Consulate. **IF YOU ARE NOT HOLDING AN AUSTRALIAN PASSPORT** please inform us immediately, so that we may advise you of any additional requirements. In addition to the above, you may also need a re-entry permit to Australia

A COPY OF YOUR PASSPORT PHOTO PAGE WILL BE REQUIRED WITH YOUR FINAL PAYMENT TO FINALISE YOUR GROUPS AIR BOOKINGS. IF YOU DO NOT HAVE THIS, IT CAN AFFECT THE ENTIRE GROUP. WE SUGGEST YOU OBTAIN YOUR PASSPORT AS SOON AS POSSIBLE IN CASE THERE IS A DELAY IN OBTAINING BIRTH CERTIFICATES, THE CORRECT MARRIAGE CERTIFICATE OR COURT DOCUMENTS.

LAND ONLY PACKAGE

If you would like to organize your own airfares please ask us for a quote that does not include airfares, airport transfers or air taxes. Once the group has deposited, we cannot book a Land Only package as non-refundable deposits will have been paid to the Airline.

FLIGHTS

This quotation has been issued prior to the applicable flight schedule being published and therefore falls outside the current system range. Flight availability, days of operation, associated schedules, and pricing are not yet confirmed and remain subject to change. It is your responsibility to ensure you have this information. It is very important that you read this information as we cannot take any changes/additions/extensions to the Dance Tour package after this date. You cannot contact the Airline directly to make any changes. Please see charges incurred.

FORCE MAJEURE

Dance Around the World/MTA Travel will not be liable for any loss or damage arising out of or in connection with the tour where performance and/or prompt performance of the contract is prevented by reason of war or threat of war, riot, civil strike, industrial dispute, terrorist activity, natural and nuclear disasters, pandemics, fire, adverse weather conditions, hostilities or political unrest and other similar conditions beyond the control of the company.

UNUSED SERVICES

There will be no reduction or refund for any unused services for individual passengers or the group as a whole.

CANCELLATION FEES

Dance Around the World/MTA Travel acts as an agent on behalf of airlines, tour operators and suppliers. Any monies received or commitments made by us are subject to our Terms of Trade conditions and Schedule of Fees as well as any of the airlines, tour operators and/or supplier's terms and conditions. In addition, airlines, tour operators and/or suppliers may also levy their own cancellation fees (which can be up to 100%). Travel Insurance may cover these cancellation fees, this will be dependent on the situation. Refunds on some airline tickets can take up to 12 weeks for the airline to process. Refunds after full payment has been made to the overseas suppliers can also incur exchange rate differences and fees.
